- **Prevention**
  - The first workgroup meeting was held a few weeks ago. The main focus was engaging faith based communities including youth and peer education and TRU membership. All members and groups on the call had great ideas including reaching out to churches and connections to junior church community and salvation army in Lock Haven. These ideas provided all the youth organizations that already exist in order to begin outreach (Christian schools, ministires, churches). The goal is to try to get TRU ambassadors through these connections by providing scholarships and gear. Future meetings will be scheduled to further outreach outside of schools to active youth groups.
